**Important Information:**

Irons Oaks Environmental Learning Center is a joint operated facility of the Homewood-Flossmoor and Olympia Fields Park Districts (Park Districts). Irons Oaks is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. Irons Oaks continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program/activity must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activity contemplated by this agreement. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

**Warning of Risk:**

This Teams Course and recreational activities/programs are intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity/program.

Understandably, not all hazards and dangers can be foreseen. Depending on the particular activity, participants must understand that certain risks, dangers and injuries due to inclement weather, slipping, falling, poor skill level or conditioning, carelessness, horseplay, un-sportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor recreational activities/programs exist. I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I and my family further agree to waive and relinquish all claims I, or my minor child/ward may have (or accrue to me or my child/ward), as a result of participating in this field trip against the Homewood-Flossmoor and Olympia Fields Park Districts, including its officials, agents, volunteers and employees (hereinafter collectively referred as the "Park Districts").

I and my family do hereby fully release and forever discharge the Park Districts from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this field trip.
